

FEAST COAST BAYS Terms & Conditions

- 1. By participating in this competition, you confirm that you accept and agree to these Terms & Conditions.
- 2. The Promoters are the Mairangi Bay Business Association (MBBA), Browns Bay Business Association (BBBA), and Torbay Business Association (TBA).
- 3. The Sponsors are MBBA, BBBA and TBA.
- 4. The Competition is called 'Feast Coast Bays'.
- 5. The Promotional Period is from 12.01am on Saturday, 1 July 2023 to 11:59pm on Friday 11 August 2023.
- 6. Three spot prize winners will be drawn after the end of each week of the promotion, on the following dates: 11 July 2023, 18 July, 25 July, 1 August, 8 August and 15 August 2023. Winners will be notified by telephone and/or by email. If the winner(s) cannot be reached by email or telephone within two working days, the Promoters may redraw a new prize winner(s) without liability to any person.
