

# BROWNS BAY SHOPPING PROMOTION 2024 Terms & Conditions

- 1. By participating in this competition, you confirm that you accept and agree to these Terms & Conditions.
- 2. The Promoter is The Browns Bay Business Association Inc. (BBBA), PO Box 35043, Browns Bay, Auckland 0753.
- 3. The Sponsors are BBBA, House of Travel Browns Bay, Fiji Airways and New World Browns Bay.
- 4. The Competition is called 'Browns Bay Shopping Promotion 2024'.
- 5. The Promotional Period is 12.01am on Monday 8 July to 11:59pm on Saturday 31 August 2024.
- 6. The draw will be held on Monday 2 September 2024, and the winners will be notified by telephone and/or email. If the any of the winners cannot be reached by email or telephone within three working days, the Promoter may redraw a new prize winner(s) without liability to any person.
- 7. Information on prizes and how to enter form part of these Terms and Conditions of entry.
- 8. To enter the Competition, you must make a purchase of at least \$20 at any participating retailer or business in Browns Bay where entry cards with unique codes are available.
